The trip is sponsored by *Success Through Scriptures*, a ministry encouraging men through expeditions into the Creator's great outdoors. Based out of the only resort on a pristine, ten-mile long Canadian lake, you'll enjoy lots of time on the water as well as daily "fishing" adventures in Proverbs. Add to this delicious meals, quality boats, excellent dock service, and lots and lots of fish! (We boated 2000+ in 2016!)

TRIP #1 June 20-24 Three and a half days of fantastic fishing! Departing early morning Friday, June 20th, fishing all day Saturday, all day Sunday, all day Monday. Departing early morning Tuesday, June 24th. **Cost: \$950**

Crow Duck is the largest lake in Whiteshell Provincial Park (eastern Manitoba) about 100 miles north of the US border and two hours east of Winnipeg. Since there are no roads to Crow Duck, owner Bill Kolansky will pick us up on Big Whiteshell Lake. From there it's a two-mile boat ride to a private trail that leads to the camp which is the only property on the lake. The two-mile truck ride through wilderness bush country is a refreshing end to the journey and an exciting beginning to our fishing adventure. Crow Duck is a remote lake with no roads, no private cabins, and nothing but fantastic fishing and spectacular scenery.

WALLEYES Crow Duck Lake has awesome fishing! Expect to catch large numbers of quality fish (average 19-20"). If you choose to, you can join us as we hike to **Saddle Lake** (1.25 m portage) to fish as conditions warrant. Plan on taking fish home as well as enjoying a fresh fish dinner. Saddle Lake is an amazing lake to fish and has been a gold mine for walleyes (20"+ common!).

SMALLMOUTH "If you are after lunker bass, Crow Duck Lake is your dream come true!" says the owner. "Bass fishing is fantastic here, in cool

or hot weather. Most of our customers come here for excellent bass fishing. Expect to catch lots of nice bass and you have an excellent chance of finding a 'Master Angler Award' (18" or more) bass here." The lake has excellent bass habitat with 75 miles of rocky shoreline, underwater rock piles, and many weed beds. Two group members earned Master Angler honors in 2017. We proved last year that Saddle Lake has big smallies, too!

Our guide pre fishes the lakes 1 or 2 days before we get there to see if the fish are active (biting) and the type of bait or lure used and the location on the lake.

Before we get to Canada, our guide will also give us his live GPS location on the lakes on our IPhones so we can see his live location and do live Facetime, watching him catching walleyes and smallmouth bass at the rate sometimes of catching a fish every 2 minutes.

In June 2022, I did live Facetime for 7 minutes with Titus our guide and I saw him catch 3 walleyes during that time! What a great job he does!

On one of the portage lakes in 2019 with 2 days of fishing, we caught approximately 250 walleyes. That wasn't unusual, but the average size of walleye was VERY UNUSUAL!



ishing was a bit slow one balmy July morning on Crow Duck, due more likely to the guide than the windless conditions. My two fishing partners, Jeff Human and his teenage son, Lucas, were content, but they jumped at the chance for an adventure.

"See that big hill," I asked, pointing to the highest summit on Crow Duck. "Want to be the first ones to climb it?" There was no hesitation. There was also no trail, but we got up there anyway. The view was incredible. So was the achievement. In fact, every year thereafter I'd ask my boat partners, "Hey, anyone want to climb 'Mount Human'?"

Special spots deserve a special name. On another July STS trip, the weather was super-hot with temps one degree short of 100 and humidity one point above. My brother, Dave, and his good friend, Don, were pitching plastic for smallies with much success. In one stretch, Don, dripping wet in sweat, was on fire, hauling in several healthy bronzebacks in succession. The massive shelf of rocks towering above us begged for a name. "Onyshuk Bluff" was the perfect fit.

A few years later, a couple of boats joined me in the bay across from Onyshuk Bluff. The action was ridiculous, with walleyes coming out of the water at times one a minute. On another trip to same hole, a friend and I boated over 100 walleyes in just two hours after dinner! An STS rookie named Cal Otto was especially hot, so much so that the location became famous overnight as "Otto-Matic Point."

f you have experienced a little more of life, a Christian faith, or a specific skill than someone else, than you are in a position to share your experience with someone less fortunate. Throughout my life, I have observed teenagers who are looked up to and emulated by younger school-aged children; or where someone who has been a Christian for several years, has studied the Bible, and grown in his faith can be a big help to a younger Christian.

So what is a mentor? The dictionary definition says its a trusted counselor or guide. As we strive to gain wisdom for our own lives, we can make tremendous

contributions by building into relationships with younger people in order to become a trusted friend. Hopefully, when faced with struggles, that the young person turns to a mentor for advice. Whether a dad or grandparent, mentoring occurs first with one's own children, but many younger people need an adult other than their parents to give another perspective.

Many young people are struggling today; anxiety and depression among

teens and young adults is near epidemic levels. Pressures from social media, overly busy schedules, and the perceived needs to perform in school, sports, or to keep up with friends weighs heavily on today's youth. Also, there are many important decisions—choosing a career, where to get an education and paying for it, who to marry.

More seriously, this is a time of questioning whether the faith they grew up with is what they should believe and make it their own or not. Many quit going to church after leaving their parents homes, or, while attending college, their faith is attacked, being exposed (indoctrinated) to destructive world-views. Many have

grown up without fathers in the home or divorced parents, leaving hurts and scars. This pain and depression is often dealt with by harming themselves.

There is an urgent, real need for caring adults to mentor younger people. Some of us have experienced a stable family life, with both a mother and a father who loved us—yet many kids don't have that advantage. Previous generations did not have the same pressures as most kids today. Are those differences a hindrance in providing encouragement to a young person?

One of the most important factors in helping a young person is to show you care and carefully listen

to concerns. Having gone through a similar struggle they might be facing can be valuable in giving encouragement and a fresh perspective. One of the best ways to develop such a relationship is to find activities that both adult and young person can enjoy doing together.

So, how does one become a trusted mentor? It does not require a lot of education, money, specific skills, or even have your own act together. For some, it might be volunteer-

ing with a sports team and befriending through interaction. The goal of Success Through Scriptures Ministry is to have caring adults, who love the outdoors and fishing, provide an example of a Christian faith by incorporating scriptural principles into men and boys while enjoying God's creation. Another opportunity is to talk to a youth pastor about your willingness to mentor a youth who might be interested in such a relationship. Not all young people are interested, but some would welcome the opportunity and this can be valuable for both persons involved. It only takes humility and a willingness to listen—then both can learn and grow, sharing experiences and planting seeds of wisdom. • ms

ave you ever noticed that most modern Christian ministries in local churches take place within the confines of their walls, usually in the fellowship hall? In the summer of 2005, the Lord impressed upon us to start the ministry now known as Success Through Scriptures (STS).

"The Honey Hole," for one, is a traditional go-to favorite, marking the spot in Rice Bay where walleyes and pike stack up as the water warms. "Phil's Bay" and "Petty's Pool" are newer names, each with its own story. Next time you have the fun of fishing in the Whiteshell's finest, you might just want to try tagging your own secret spot.



The portage to Saddle Lake leads to more legendary sites. "North Concord Shore," for one, can be found just up from the landing on the west side and always the first (and sometimes only) stop for the gang from West Concord, Minnesota. Last year, I added "Gaylord's Bay" to the list, named after a friendly guy who showed our struggling team where the action was to be found on the east side. And we nailed 'em!

One location that will forever lure me in is "Adulterous Point," found just over the saddle. Named for the wayward woman warned of in our GPS studies (Proverbs 5-7), this hotspot irresistibly tempts unsuspecting fishermen with its classic structure and healthy walleye population. What's more, we've found that Saddle Lake's biggest 'eyes seem to hole up there. Ah, but there is a price to be paid, weighed out in the ton of lead sacrificed to the huge boulders below.

Space doesn't permit to tall

Space doesn't permit to tell the stories of "Fitzgerald Point," "Schachterle Island," "Walleye Jacuzzi," "Lonski Tree," or a host of others. But when it comes to naming rights, everything is in play—including boat teams ("Three Amigos") and fishing techniques.



A few years back, I got to fish solo with long-time friend, Steve Winje, on his first trip to Canada. He not only hooked his first walleye, but he caught more fish in one day than in his whole life combined! It was understandable, then,

that he needed a little coaching on first hooking and then boating his fish. By day's end, the net stayed in the bottom of the boat and the "Winje Method" was perfected. Taking advantage of a fish's own momentum to rocket it into waiting hands proved to be great entertainment!

When it comes to naming rights, the Creator God stands as the ultimate authority not only on all these amazing places to fish, but on the fishermen themselves. Thanks to the One who has a name above all names, He alone can write our name where it matters most—in his Lamb's Book of Life.

Bill Abeler made nine STS trips to Crow Duck from 2008-2017, eight as the GPS teacher. The Executive Director at Camp Lebanon (Upsala MN), "Bobber Bill" graduated from the University of Northwestern—St. Paul and Trinity Evangelical Divinity School.

"I had fished off and on throughout my life, but never with much success. I kept hearing how great the fishing was up in Canada and decided to give STS a try. I was not sure what to expect, but figured it would be fun to learn how to fish from a bunch of guys who knew what they were doing. I caught more fish that first day than I had in my entire life and was literally hooked."

Is there anything I can do to guarantee myself a long life?

ANSWER

"Honor your father and mother'-which is the first commandment with a promise-'that it may go well with you and that you may enjoy long life on the earth" (Ephesians 6:3-4).In this passage, the apostle Paul is quoting from the Ten Commandments, Exodus 20:12, specifically: "Honor your father and your mother, so that you may live long in the land the LORD your God is giving you." This represents the only instance of God connecting long life as a reward for something we do. Is this promise of long life for honoring your parents true? And, if so, why is honoring your parents so highly valued to God that He rewards it with long life?

First, yes, the promise is true, but not in a universal sense. There are people who honored their parents but died young. And there are people who did not honor their parents but lived a long life Therefore, it is a principle that is generally true. If you honor your parents, God will, generally speaking, reward you with a long life. However, this promise does not override other decisions we make that impact how long we live. For example, if a man honors his parents, but then decides to commit suicide, the act of suicide "negates" the reward of long life. The same can be said of thos who engage in reckless and dangerous activities. God's reward of long life for honoring parents does not miraculously make you immune from serious injury or death.

Again, the reward of long life for honoring your parents is a general principle, not a universal truth God considers the way a child treats his/her parents so important that He usually rewards those who honor their parents with long life. Solomon urged children to respect their parents (Proverbs 1:8; 13:1; 30:17). Jeremiah 35:18-19 describes how God blessed the Rechabites for obeying their father. Disobedience to parents is a trait of those who rebel against God (Romans 1:30; 2 Timothy 3:2). This brings us to the second point. Why is honoring your parents so highly valued to God the He rewards it with long life?

There are at least two reasons for the value God places on honoring your parents. First, God entrusts parents with the responsibility to raise their children in a godly manner. The task of parenting is not easy. It is painful, stressful, expensive, and often unappreciated. For a child to no recognize, and be grateful for, the sacrifices parents make on his/her behalf is an affront to the position of authority and value God has given to parents. It is similar to how we are to respond to the government (). If God has placed us under authority, to rebel against that authority is to rebel against God Himself.

The second reason God desires us to honor our parents is because our relationship with our earth parents is an illustration of our relationship with our Heavenly Father. For example, Hebrew 12:11 compares the discipline a child receives from parents to the discipline believers in Christ

received from God. Just as our parents are our biological progenitors, God is our Creator. We are children of God and children of our parents. To dishonor our parents is to distort the picture of what our relationship with our Heavenly Father is to be.

Do you want to live a long life? Honor your parents. Why? Because God placed you under their authority and guidance, and because your attitude toward your parents is illustrative of your attitude toward God. While this reward is not universal-and while it does not override every oth decision you make-it is still generally true. If you want to live a long life, honor those who gav, e life in the first place.
